CERTIFICATE OF ANALYSIS

Source: An E.coli strain that carries the cloned Hind III genel from Haemophilus influenzae Rd.

Supplied in:

10 mM Tris-HCl (pH 7.5), 200 mM NaCl, 0.1 mM EDTA, 200 µg/ml BSA, 1 mM DTT, 50% glycerol.

Reaction Conditions:

1x SE-Buffer W ,BSA (100 μ g/ μ l). Incubate at 37° C.

1X SE-Buffer W (pH 8.5 @ 25° C):

10 mM Tris-HCL 100 mM NaCl 10 mM MqCl₂ 1 mM DTT

Heat Inactivation: Enzyme is inactivated by incubation at 80 °C for 20 minutes.

Unit Definition: One unit is defined as the amount required to digest 1 μg of λ DNA in 1 hour at 37° C in a total reaction volume of 50 µl. To obtain 100%

activity, BSA should be added to the 1X reaction

mix to final concentration of 100 µg/µl.

Quality Control Assays

Ligation: After 50-fold overdigestion with Hind III, approximately 90% of the DNA fragments can be igated with T4 DNA Ligase and recut.

resulted in the same pattern of DNA bands as a reaction incubated for 1 hour.

Oligonucleotide Assay: No detectable degradation of a single-stranded and double-stranded oligonucleotide was observed after incubation with 10 units of restriction endonuclease for 3 hours.

16-Hour Incubation: A 50 µl reaction containing 1 µg

of DNA and 10 Units of enzyme incubated for 16 hours

Enzyme Properties:

When using a buffer other than the optimal (Supplied) SE-Buffer, it may be necessary to add more enzymes to achieve complete digestion.

Reagents Supplied with Enzyme: 10X SE Buffer W, BSA (10 mg/ml).
